We take reasonable measures to protect your personal information from unauthorized access, use, disclosure, alteration, or destruction. However, no method of transmission or storage is completely secure, and we cannot guarantee the absolute security of your information.

We retain your personal information for as long as necessary to fulfil the purposes for which we collected it unless a longer retention period is required or permitted by law. Full details of data retention can be found on our Data Protection Policy.

Members under the age of 18

We collect information that you voluntarily provide for juniors under the age of 18 when they join as a member, fill out a form (online or paper based), or contact us. This may include their name, email address, telephone and mobile numbers, date of birth, and other details that you choose to share with us. We do not knowingly collect or solicit personal information from juniors under 18. If we become aware that we have collected personal information from a junior under 18, contact help@wilsoniansc.org.uk where we will delete it as soon as possible.
